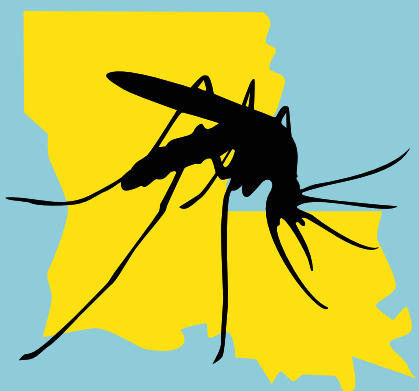

All exhibitors are expected to keep all displays within their allocated booth space (10 feet wide for a single booth, 20 feet wide for a double booth). Disclosures

Payment and Cancellation:

It is expressly agreed upon that all payments for requested exhibit space be made by Friday, November 13, 2026. LMCA reserves the right to refuse an exhibitor an exhibition space for reason of non-payment and / or unpaid balance at the time of installation. If an exhibitor is unable to attend the meeting a refund may only be issued for the booth fee if notification is received by the LMCA office **Friday, November 13, 2026**. Payment for event sponsorships (meals, coffee breaks, ads, etc.) are non-refundable.

Badges:

Exhibitors will receive one complimentary registration and membership for every \$350 purchase or donation to the meeting. Please be sure to indicate the names of your staff that will be receiving the complimentary registration(s)/membership(s). Badges must be worn at all times during the conference.

Shipping:

Storage facilities for packing cases, crates, and boxes are not available at the hotel. It is the responsibility of the vendor to arrange shipment and storage.
